4. Judging will be on the basis of the year's activities from the previous January 1 to November 1 of the current year. Dates of activities must be shown.
5. Email a professional headshot (hi-resolution, color) of nominee to Jennifer Lundy (jlundy@garealtor.com) at GAR by the deadline date and time.
6. Entry must be faxed or emailed to the GAR office [770-458-6992] by 5:00 p.m. on the deadline date. Association executives will receive a confirmation notice when all materials are received.
7. Entries received that do not adhere to the above criteria will be automatically eliminated and returned without consideration. There will be NO EXCEPTIONS made.
8. You may nominate yourself or nominate multiple REALTORS® as long as the above criteria is met.

The Special Recognition Committee will be requested to consider applicant's total personality and lifestyle to insure that the winner will be held up to the public as "the best of us."
